Resource Levy

This levy covers excursions, camps (Year Level), student resources (physical and online), Primary School and Year 7 stationery, sports and HPE levies, subject levies and consumables. Some co-curricular activities are excluded. Camps are a valuable and important part of the curriculum and are compulsory for all students. Their costs are non-refundable.

Mobile Device Levy

Students are provided with a mobile device/s in nominated year levels. The device is owned at the end of the three-year cycle, subject to full payment of the rental amount and all College fees. Students who leave the College before the end of a designated cycle can negotiate to purchase the device, dependent upon the term left on the rental cycle. Alternatively, the device must be returned to the College. All devices are required to be restored to factory settings at the end of the program prior to ownership being transferred.

External Studies

Additional external studies tuition fees (senior secondary years) may apply and are the responsibility of the family. Pursuing this pathway does not result in a reduction of the tuition fees payable at Immanuel Lutheran College. A formal agreement between the college and the family is entered into before any student enters this pathway.

Parents and Friends Community Levy

The Parents and Friends Community provides a means of support, information and involvement for parents, caregivers and guardians of enrolled college students. A \$60.00 levy is billed on a per family basis, at the start of each year in the Semester One Fee Statement.

Application and Enrolment Confirmation Fees

There is a non-refundable *Application Fee* of \$200.00 per child.

To secure enrolment, a non-refundable *Enrolment Confirmation Fee* of \$900.00 per child is to be paid within fourteen (14) days of receipt of an Enrolment Contract Agreement being offered.

Early Payment Discount

An early payment discount is available if the full year's fees (tuition fees and levies) are paid by no later than 4:00 pm Friday, 30 January 2026

- Early payment discount for students in Prep to Year 6 \$300.00
- Early payment discount for students in Years 7 to 12 \$400.00

Sibling Discount

Sibling discount is available to families who have more than one sibling enrolled at the College during a school year. This discount is applied to the tuition component of the fees and is only available to parents who are not in receipt of any greater concessions.

- Second Child - 10% discount on tuition fees
- Third Child – 30% discount on tuition fees
- Fourth and Fifth Child/ren - 50% discount on tuition fees
- Sixth and Subsequent Child/ren - 100% discount on tuition fees

Fee Concession

The College provides fee concessions to compassionately support families where special circumstances exist due to financial hardship. Should you require further information, please contact the Head of Business Operations on T: 5477 3435 to arrange a confidential appointment.

Payment Dates

College Fees are invoiced twice per year, prior to the commencement of each school semester. Semester fees are due no later than the first Friday of that semester.

In 2026, due dates for fees are as follows:

- Semester One - Friday, 30 January 2026.
- Semester Two – Friday 17 July, 2026.

The College offers three payment methods:

- Full payment of the annual invoice by the due date of semester one
- Full payment of the semester Invoice by the due date of each semester
- Direct debit payment plan – (Formal plan as arranged with the Business Office on either a weekly/fortnightly agreement with full payment due by 6.11.26 (no additional fees incurred)

Fees Policy

A student may not be permitted to commence a new school term unless the school fees for the previous semester have been paid in full or an agreement has been reached with the Head of Business Operations. A \$50.00 Administration Fee will be added to the account if the account is not paid by the due date. Immanuel Lutheran College reserves the right to withhold school reports and Year 12 exit certificates should fees remain unpaid at the end of a school year.

Withdrawal of Student/s from the College

Parents are required to give ten (10) weeks' notice formally in writing, via email, to the Enrolments Registrar if they intend to withdraw their child/ren from the College. A full term's tuition fees will be charged in lieu of sufficient notice.
